

Movement in Mobile Messaging and Communication Technology: Throughout October, strategic buyers acquired a number of communication and messaging technology providers, particularly those in the mobile space.

The largest of these transactions occurred when Nimbuzz B.V., an early player in mobile messaging with a significant Indian userbase, was acquired by New Call Telecom Ltd., one of the UK's leading telecom services providers. The transaction values Nimbuzz at an enterprise value of \$250.0 million, and is in line with New Call's objectives to expand their presence in the Indian market.

Earlier in the month, **Txtlocal Ltd.**, a cloud based, mobile messaging business targeting small and mid-sized businesses ("SMBs") in the UK, was acquired by mobile communication technology and service provider **IMImobile Limited (AIM:IMO)**. The transaction values Txtlocal at an enterprise value of \$21.1 million, or 1.9x revenue. The acquisition further enhances IMI's mobile engagement product suite, while simultaneously opening up the SMB market.

Also in October, Link Mobility Group ASA (OB:LINK), a leading provider of mobile software and services in the Nordic and Baltic region, acquired PSWinCom AS, a supplier of B2B mobile solutions for messaging and payment in Norway. The transaction values PSWinCom at 0.9x revenue and an enterprise value of \$11.9 million. The deal strengthens Link Mobility's position as the largest provider of mobile solutions in the Norwegian market.

Other transactions occurring during October include: Maintel Holdings Plc (AIM:MAI) acquiring Proximity Communications plc for \$18.7 million; and Yahoo! Inc. (NasdagGS:YHOO) acquiring LittleInc Labs, Inc.

Might the demand for mobile messaging and communication technology providers remain strong in the coming months?






