





Visible Activity in the Education Technology space: Throughout the month of February, a number of strategic and financial buyers were active in acquiring companies that provide education technology across the globe.

The most notable of these transactions occurred when the PE firms, **The Vistria Group, Apollo Global Management** (NYSE:APO), and Najafi Companies, entered into an agreement to acquire Apollo Education Group (NasdaqGS:APOL), which operates an online educational portal under University of Phoenix, at a valuation of \$408.8 M, 0.2x revenue, and 1.4x EBITDA. In the midst of falling enrollments and shrinking profits, the new owners believe they can lead a clean-up of the for-profit education industry which has been criticized for saddling students with outsized loan debts and subpar instruction.

In early February, **Vtech Holdings (SEHK:303)**, a global supplier of e-learning products, launched a takeover bid to acquire **LeapFrog Enterprises (NYSE:LF)**, which develops educational entertainment for children. The transaction values LeapFrog at \$40.5 M and 0.2x revenue. Vtech believes it will further broaden its portfolio of educational technology products as well as strengthen its offerings in electronic devices with the inclusion of the LeapPad tablets. After LeapFrog's string of unsuccessful product launches over the years, Vtech believes it can turn its fate around to better compete against devices like the ubiquitous iPad.

On February 26, **ZG Ventures**, a tech focused private investment firm, agreed to acquire **Cricket Media Group** (TSXV:CKT), an education media company, with certain other shareholders. The transaction values Cricket Media at \$29.8 M and 2.1x revenue. ZG ventures will take the company private for investment purposes.

Other transactions occurring in February include **Blackstreet Capital** acquiring **Advanced Workstations in Education**; Udemy acquiring Sunnytrail Insight Labs; and Haygot Education acquiring Manch.




