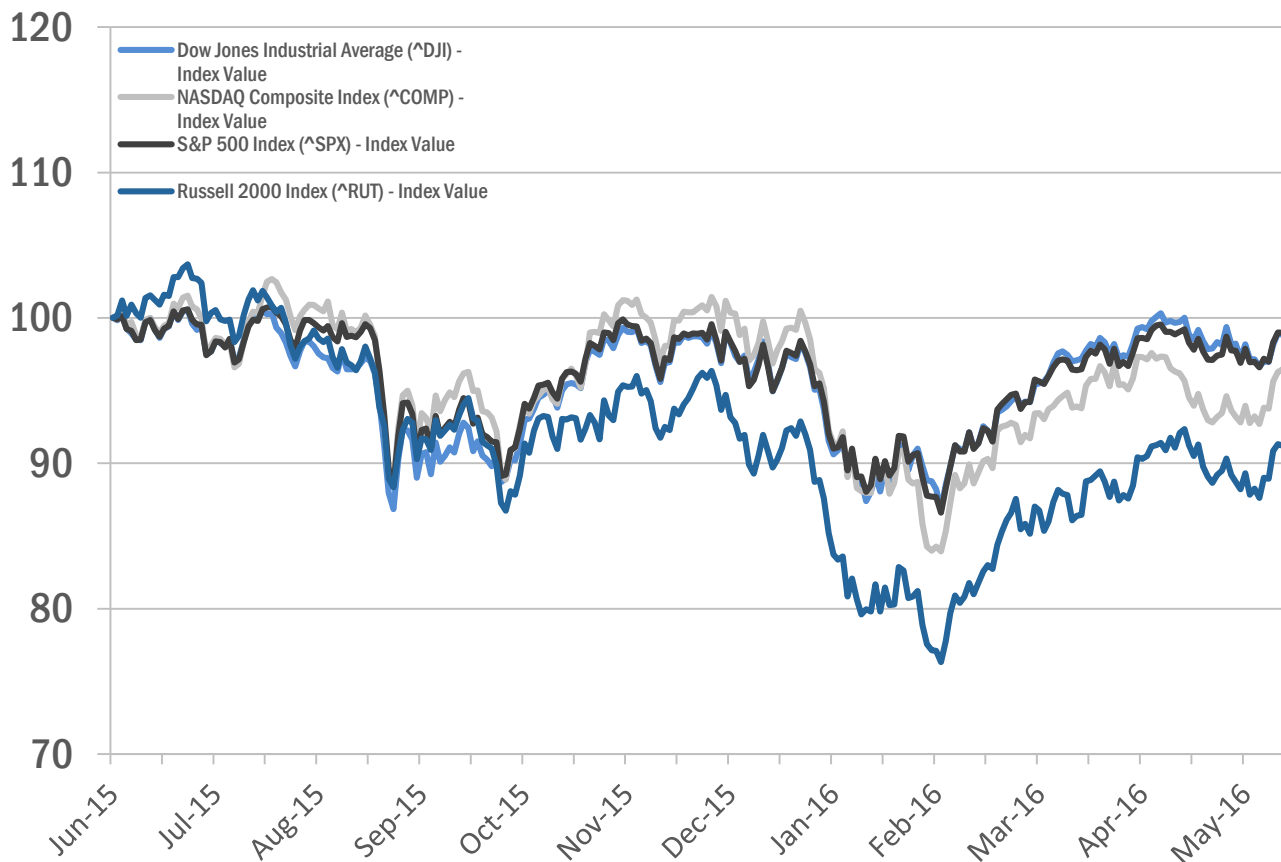

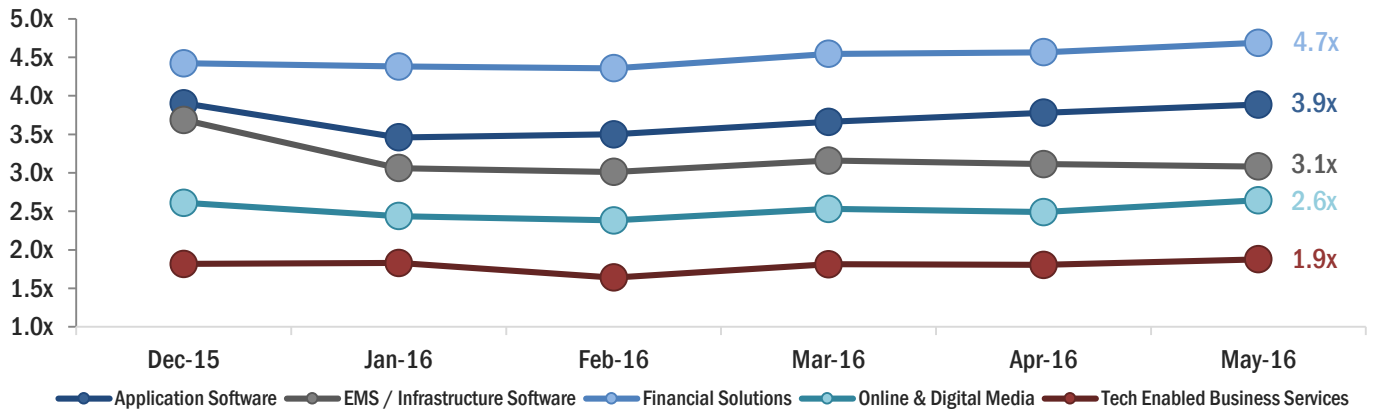

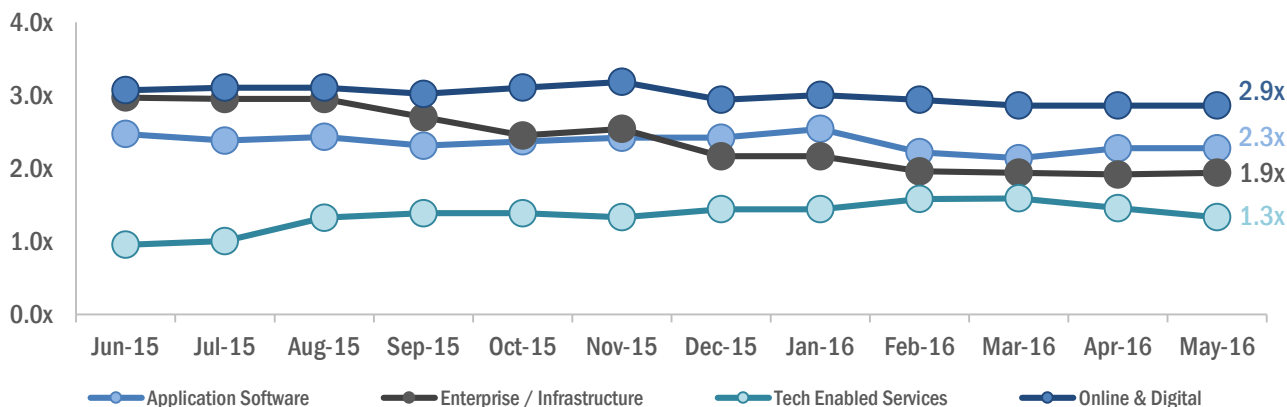

Visible Activity in the Education Technology space: Throughout May, several strategic and financial buyers were active in acquiring companies that provide education technology. Strong activity in this space continues a trend of EdTech acquisitions in 2016 that Pharus first observed in the month of March with the acquisitions of notable firms such as Apollo Education Group and LeapFrog Enterprises. The space also continues to attract larger tech acquirers such as Google joining the likes of Apple and Microsoft, both of which completed acquisitions earlier in the year.

The most notable transaction occurred when **Foxconn Technology Group (TSEC:2354)**, a multinational electronics manufacturing company, announced its plans to acquire **SMART Technologies (TSX:SMA)**, which provides interactive whiteboards and enterprise collaboration solutions. The transaction values SMART at \$196.5 M, 0.6x revenue, and 16.5x EBITDA. With access to the technological and financial resources of Foxconn, SMART believes they will be able to position themselves for significant future growth.

On May 2nd, **Alphabet (NasdaqGS:GOOGL)** announced its acquisition of **Synergise**, an enterprise software company that provides training services designed for Google Apps. The financial terms of the transaction were not disclosed. Synergise boasts a 35% higher Google Apps adoption rate for companies that employ its interactive tutorials. Through this acquisition, Google plans to integrate Synergize into its own product offerings to further accelerate adoption.

In mid-May, **Beijing Shengtong Printing (SZSE:002599)**, a provider of commercial print services, announced plans to acquire **Beijing Lebolebo Special Education Technology**, which operates an online robot education platform and manufactures educational robot kits, at a valuation of \$65.9 M.

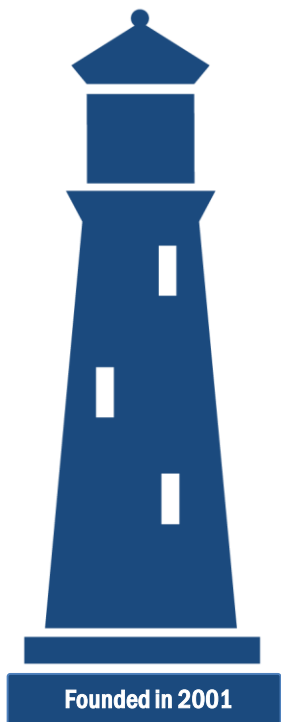
