



Visible Activity in the Digital Marketing Solutions Space: Several strategic buyers were acquisitive in the digital marketing solutions space throughout October. Global digital advertising is expected to experience significant activity with an estimated 2014-2019 CAGR of 12.7%. By 2019, 50% of total global media spending is estimated to come from digital [McKinsey]. With ongoing focus on digital in the global media space, Pharus continues to see a strong trend in acquisitions of companies that strengthen digital marketing capabilities and create a more seamless experience.

The most notable transaction occurred on October 21st when **Ziff Davis**, a global digital media subsidiary of **j2 Global** (NasdaqGS:JCOM), announced its acquisition of **Everyday Health** (NYSE: EVDY), which provides digital health marketing and communications solutions. The transaction values Everyday Health at \$459.3 million. Co-Founder and CEO of Everyday Health, Ben Wolin, believes the acquisition "delivers significant and immediate cash value to shareholders," and "positions [the company] to reach its next phase of growth."

On October 11th, **YouTube** announced that it acquired **FameBit**, a digital marketing platform that enables brand marketers to connect with video creators. The financial terms of the deal were not disclosed. Google's Vice President of Product Management, Ariel Bardin, revealed that FameBit's technology and expertise will likely help increase the number of branded content opportunities available allowing not only content creators to monetize their work, but also brands to easily find suitable influencers to promote their message.

On October 4th, **Criteo (NASDQ: CRTO)**, a performance marketing technology company, announced its acquisition of **HookLogic**, which operates as a performance marketing exchange for manufacturers and hotels, for \$250 million. Criteo believes that the acquisition will strengthen the company's performance marketing platform allowing them to delivery deeper value to brand manufacturers and retailers.
